

TERMS & CONDITIONS OF ENTRY –
Cartoon Network Christmas Countdown (“Competition”)

1. Information on Prizes and how to enter Cartoon Network Christmas Countdown (“Competition”) forms part of these Terms & Conditions of Entry.
2. Entry to the Competition is open to Australian and New Zealand residents aged up to 16 (as at 1 December 2011) with the consent of a parent or guardian (“Eligible Entrants”). Employees (and their immediate families) of the Promoter, its related companies and advertising agencies may not enter the Competition. No purchase is necessary to enter the Competition. By entering the Competition, entrants accept these Terms & Conditions of Entry.
3. Entry to the Competition opens at 00:01 (AEDST) on 1 December 2011 and closes at 23:59 (AEDST) on 24 December 2011 (“Promotion Period”).
4. To enter the Competition, an Eligible Entrant will be required to go online to www.cartoonnetwork.com.au and complete the online entry form. Eligible Entrants may enter the Competition a maximum of one (1) entry per day throughout the Promotion Period.
5. All prize draws for the Competition will take place at 11:00 (AEDST) at Oxygen Interactive Marketing, Level 1, 16 Palmer Parade, Cremorne, VIC 3121.
6. Daily Prize Draws: Starting from 2/12/11, a prize winner will be drawn each day of the Promotion Period, unless the day is a Saturday, Sunday or a Victorian Public Holiday, in which case that day’s draw will take place on the next business day at a time immediately before that day’s draw.
