

**TERMS & CONDITIONS OF ENTRY –  
Looney Tunes Cwazy Cwmpetition (“Competition”)**

1. Information on Prizes and how to enter Cartoon Network’s: ‘ Looney Tunes Cwazy Cwmpetition (“Competition”) forms part of these Terms & Conditions of Entry.
